ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is THE MATADOR AND HIS LADY, INC.
With a mailing address of 2905 Victoria Pl., E-3, Coconut Creek
Fl. 33066.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at
the time of filing these articles with the Secretary of the
State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in the
entertainment field as performers, travel arrangers (such as
transportation and food), importers or any other legal and lawful
act or activity for which corporations may be organized under the
laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of One
Dollar (\$1.00) par value voting common stock, which shall be
designated "Common Shares". Also is authorized to issue 1000
shares of One Dollar (\$1.00) par value non-voting stock, which
shall be designated "Common B Shares".

Except as otherwise provided by law, the entire voting power for the election of directors and all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at which it is offered to others.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

Eighty-five percent (85%) of the shares entitled by vote, represented in person or by proxy, shall constitute a quorum at a meeting of shareholders.

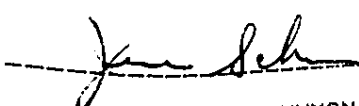
ARTICLE XII - INDEMNIFICATION

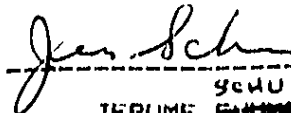

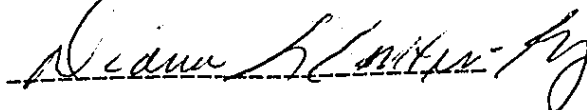

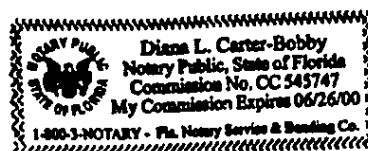
