**ARTICLES OF INCORPORATION
OF
J.M.K.P. GROUP, INC.**

The undersigned, for the purposes of forming a corporation under Florida law hereby adopt the following Articles of Incorporation:

**ARTICLE ONE
NAME**

The name of the corporation is J.M.R.P. GROUP., INC.

**ARTICLE TWO
PURPOSE**

The general nature of the business to be transacted shall be for any lawful purpose for which businesses may be incorporated under the laws of the State of Florida.



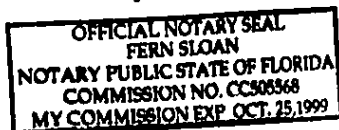
