Articles of Incorporation

The undersigned person, acting as incorporator for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

Article 1. The name of the corporation is Technical Systems Support Group, Inc.

Article 2. The purpose for which this corporation is organized is to transact any and all lawful business for which corporations may be organized under the laws of the State of Florida, and to have all powers which are afforded to corporations under the laws of the state of Florida.

Article 3. The duration of this corporation shall be perpetual.


Article 12. This corporation shall have preemptive rights for all shareholders.
