ARTICLE I

The name of this corporation is: **PAUL GREGORY CORPORATION.**

ARTICLE II

The purpose of this corporation is to buy and sell real estate and any and all other lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE V - PRE EMPTIVE RIGHTS

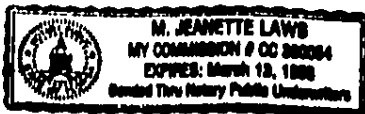

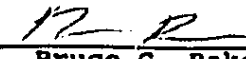

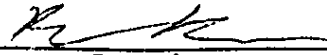
