Articles I

Name, Principal Place of Business, and Duration.

The name of the Corporation is PEDRO F. PARRA, P.A. The principal place of business of the Corporation es 3204 HAMMERSMITH RD, Orlando, Fl. 32818. The duration of he corporation is perpetual.

Articles II

Registered Office and Agent
