I am writing to request a waiver of the late filing penalty for the 1999 Annual Report for Apparel Consulting Services, Inc., My client, the owner of Apparel Consulting Services, Inc., is a diligent, conscientious elderly gentlemen. He retains my services to assist in meeting all tax compliance matters. Due to his age, he does not always understand or remember my directions.
