ARTICLES OF INCORPORATION  
OF  
ARVESTER, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, subscribes to and forms a corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation is: ARVESTER, INC.

**ARTICLE II - NATURE OF BUSINESS**

The corporation shall engage in any activity of business permitted under the laws of the United States and of this State. These activities may include, but are not limited to the operation of the following business:
