The undersigned subscribers to the articles of incorporation, KURT STAPLETON and JOEL MANZELLA, who are natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I

Name

The name of this corporation is STAPLETON & MANZELLA ROOFING AND CONTRACTING, INC. The mailing address of the corporation is: P.O. BOX 14105, Bradenton, Florida 34280.

ARTICLE II

Term of Existence

The date when corporate existence shall commence shall be the date of subscription and acknowledgment of these articles and the corporation shall have perpetual existence thereafter.

ARTICLE III

Nature of Business
