ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name and address of the corporation is PATRICK & LAURA, INC., 291 Wertz Drive, Largo, FL 34641.

ARTICLE II. NATURE OF BUSINESS

The nature of the business and the objects and purposes to be transacted, promoted and carried on are to do any and all of the things necessary to conduct a cleaning service. In addition, this corporation may do all these things as well as all of the following as fully and to the same extent as a natural person might or could do.


