We incorporated on May 21, 1996 at which time we paid our 1996 annual filing fees. At the time we incorporated, we were located in Plant City, Florida. We then moved to Orlando, Florida. Being new business owners, we didn't realize that we were required to notify the Department of State of our relocation.
