*The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:*

**ARTICLE I**  
**NAME OF CORPORATION**

**ARTICLE II**  
**PURPOSE**

*The nature of the entity is a corporation which is being organized for the purpose of transacting any and all lawful business including, but not limited to, engaging in the activities of researching and managing personal injury cases.*

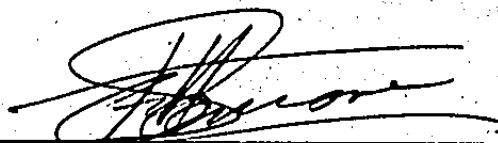
**ARTICLE VIII

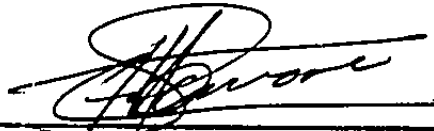
