ARTICLE I NAME

The name of the corporation shall be VIRGINIA M. V. BUKI, MD PA.

ARTICLE II PURPOSE



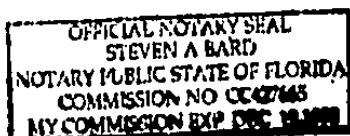
