ARTICLES OF INCORPORATION

NJM CORPORATION

ARTICLE I. NAME

The name of this corporation is NJM CORPORATION

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

The date when corporate existence shall commence is the date of the filing of these Articles of Incorporation

ARTICLE III. DURATION

This corporation shall exist perpetually, commencing on the date referred to in Article II above.

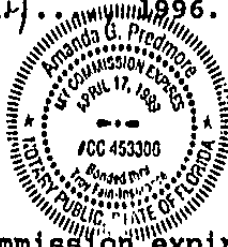

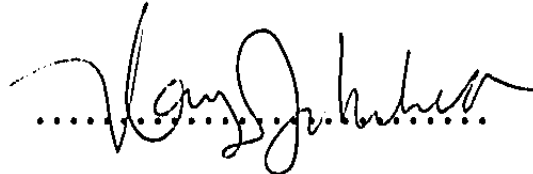
