**ARTICLE V - ADDRESS OF PRINCIPAL OFFICE**



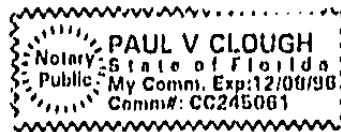
