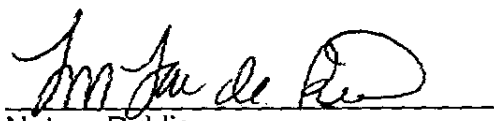
1. The name of the corporation is: Custom Connections, Inc.

RESOLVED that the Articles of Incorporation shall be amended so that Article One is eliminated, and the following substituted for Article One:

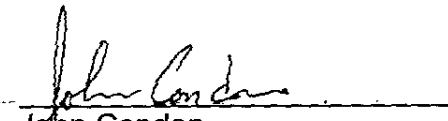
