THE UNDERSIGNED, acting as Incorporators of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:

ARTICLE I

The name of the corporation is: FLAMINGO CHIROPRACTIC OF DEERFIELD BEACH, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida, specifically to conduct the general practice of chiropractic services and all activities and operations connected therewith throughout the State of Florida.
