**ARTICLE I - NAME**

The name of the corporation **WORK AT HOME, CORP.**, located 8006 S.W. 157th Court, Miami, Florida 33193.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

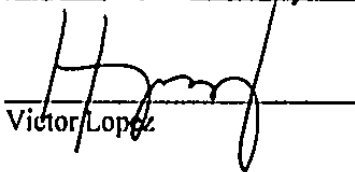
#### **ARTICLE X - INCORPORATOR**
