# ARTICLES OF INCORPORATION

The undersigned acting as incorporators of a corporation under the Florida Goteral Corporation act adopts the following Articles of Incorporation for their corporation.

#### ARTICLEI

#### **ARTICLE II**

The period of duration of the corporation is perpetual.

Shares of the corporation are not to be divided into the classes. The corporation is not authorized to issue shares in series.
