

ARTICLES OF INCORPORATION

1 CORPORATE NAME - The name of the Corporation is:

VICTORIA CONKLIN, P.A.

2 PRINCIPAL OFFICE - The principal place of business and mailing address of the corporation shall be:

3 PURPOSES - The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

7 INFORMAL SHAREHOLDER ACTION - Any action of the Shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all of the Shareholders entitled to vote upon such action at a meeting and filed with the Secretary of the corporation as part of the corporate records.

8 BOARD OF DIRECTORS - The corporation shall have a Board of Directors consisting of one (1) person. The number of Directors may be increased or decreased from time to time by a resolution of the majority of the Stockholders but shall never be less than one (1). 9 INFORMAL DIRECTOR ACTION - Any action of the Directors may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all of the Directors entitled to vote upon such action at a meeting and filed with the Secretary of the corporation as part of the corporate records. Such action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

10 SEVERANCE AND TERMINATION OF EMPLOYMENT - If any officer, director, stockholder, agent or employee of this corporation becomes legally disqualified to render the professional services for which the corporation is organized, or accepts employment that places restriction or limitations on his or her continued rendering of such professional services, he or she shall forthwith sever all employment with the corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the corporation on account of professional services. The corporation shall forthwith, upon such disqualification of any shareholder, purchase such shareholder's shares and pay him or her all amounts owing and lawfully due to him or her by the corporation, except that such shares shall not be entitled to dividends.
