**ARTICLES OF INCORPORATION  
OF  
S. K. SMITH IRRIGATION, INC.**

**ARTICLE I**

The name of this corporation is S. K. Smith Irrigation, Inc.

**ARTICLE II**

This corporation shall have perpetual existence, unless sooner dissolved according to law.

**ARTICLE III**

**General Purpose and Nature of Business**

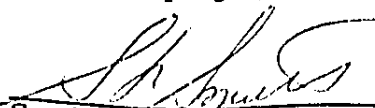

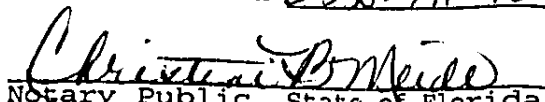
