

ARTICLES OF INCORPORATION

OF

GREAT HOMES, INC.

The undersigned, acting as Incorporators pursuant to Chapter 607 of the Florida Statutes, adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of this Corporation is GREAT HOMES, INC.

ARTICLE II. DURATION

The period of its duration is perpetual, beginning from the date these Articles are filed with the State of Florida, secretary of State.

ARTICLE III. PURPOSE

The general purpose of the business to be transacted by this Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida, and to effectuate such purposes it may act in any capacity including as an agent or attorney-in-fact for any person or entity.

ARTICLE IV. CAPITAL STOCK

This Corporation is authorized to issue 153 shares of class A stock, which shall be the only class of stock entitled to unlimited voting rights and 447 shares of Class B stock which shall have no voting rights. Class A and Class B stock collectively are entitled to receive the net assets of the Corporation. Neither class A nor Class B stock shall have preference over the other in the distribution of dividends or assets.

ARTICLE V. PRESMPTIVE RIGHTS

- A. Each of the shareholders agrees not to sell, transfer, pledge, assign or otherwise in any way dispose of his or her shares except in accordance with the provisions of that certain Shareholder Agreement to be executed upon the formation of this Corporation and which Agreement is by and between all of the shareholders of this Corporation and which Agreement prohibits the transfer of stock for certain periods and limits the transfer of stock.
- B. If additional shares are authorized, all additional shares of stock issued by the Corporation will be subject to the same restrictions regarding transferability as the initial stock.
- C. If additional shares are authorized, the holders of Class A and Class B shares will be entitled to purchase newly issued stock proportionate to their respective holdings prior to the stock being offered to outside subscribers.
