ARTICLES OF INCORPORATION MAY 22 MI 10: 52

The undersigned incorporator, being a natural person competent to contract for the F. FLORIDA purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I
