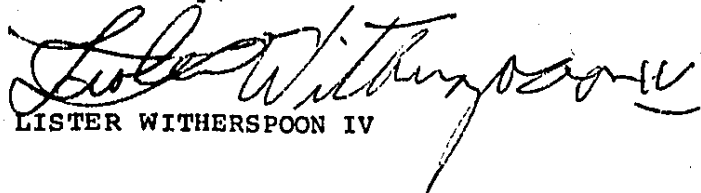

ARTICLES OF INCORPORATION

ARTICLE I

The name of the Corporation shall be:

Nature of Corporate Business

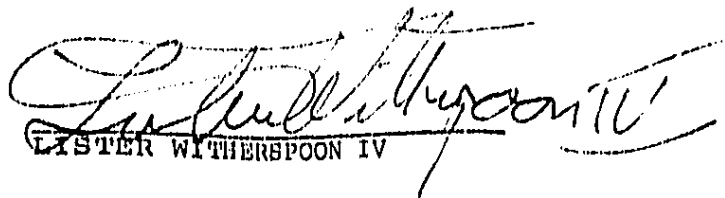
