The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

Article I. NAME

The principal place of business of this corporation shall be 4855 - 1st Avenue South, St. Petersburg, FL 33711

Article II. NATURE OF BUSINESS
