ARTICLES OF INCORPORATION

TO: SECRETARY OF STATE, STATE OF FLORIDA, TALLAHASSEE, FLORIDA

I, the undersigned natural person of the age of twenty-one or more, acting as incorporator of a corporation under title 607.164, of the LAWS of the State of Florida, adopt the following Articles of Incorporation for such corporation.

- The name of the corporation, hereinafter referred to as the Corporation, shall be Sara Waijman Designs Corporation.
- 2. The duration of the Corporation shall be perpetual.
- 3. The object and purpose for which the Corporation is formed is to engage in the ownership and management of an Interior Design business and any other business permitted by law.
