ARTICLE I - Name and Principal Office

The name of this corporation is BAY AREA LICENSE, INC.

The principal office of this corporation is
18940 U.S. Highway 19 North, Clearwater, Florida 34624.

ARTICLE II - Duration

This corporation shall have perpetual existence.

ARTICLE III - Purpose

This corporation is organized to include the
transaction of any of all lawful business for which corporations
may be incorporated under Chapter 607, Florida Statutes (1991),
as presently enacted and as it may be amended from time to time.

ARTICLE IV - Capital Stock

This corporation shall be authorized to issue one
