The undersigned individual desiring to do business in the State of Florida, hereby organizes a Florida corporation for profit.

ARTICLE I

The name of the corporation shall be INNOVATIVE INTERCULTURAL INSTRUCTION INCORPORATED.

ARTICLE II

The purposes for which the corporation has been formed are to provide a curriculum for Florida Prison System's clients that will (a) enhance incarcerated client's self esteem by giving educational and interpersonal skills the client does not presently have and (b) reduce the probability of an incarcerated client having to repeat jail sentence.

ARTICLE III

The maximum authorized capital stock of the Corporation shall be One Thousand (1000) shares at One Dollar (\$1.00) par value per share.

ARTICLE IV

The corporation shall have perpetual existence.

ARTICLE V

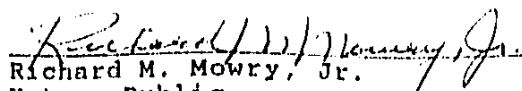

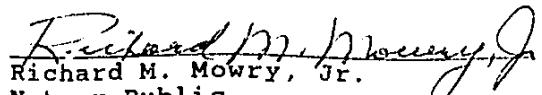
