ARTICLES OF INCORPORATION OF HOEFER ENTERPRISES, INC.

COUNTY POR THE SENSOR

ARTICLE I. NAME

The name of this corporation shall be Hoefer Enterprises, Inc.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Division of Corporation. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE
