ARTICLES OF INCORPORATION

OF

TWO BEST PALS, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is TWO BEST PALS, INC. whose principal place of business is 7311 SW 13th Street, Plantation, Florida, 33317.




