

ARTICLES OF INCORPORATION  
OF  
INDUSTRIAL STRENGTH MFG., INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is Industrial Strength Mfg., Inc.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

FOURTH: The number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000.
