This correspondence is in response to your letter dated September 5, 1996, returning the Articles of Dissolution for the above-referenced corporation.

Enclosed please find a photocopy of Section 607.1401, Florida Statutes for your easy reference. Section 607.1401 states, in pertinent part, "A majority of the **incorporators** or directors of a corporation that has not issued shares or has not commenced business may dissolve the corporation..."

The statute clearly states that an **incorporator** may file the articles of dissolution. Thus, the above articles were properly filed by the incorporator (meeting the statutory requirements of 607.1401 (1-6), and were therefore returned in error.

Furthermore, as stated in the articles of dissolution, no shares were issued or business commenced.
