In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I.  
CORPORATE NAME

The name of the corporation ("Corporation") is WRIGHT'S TRUCKING, CORP.

ARTICLE II.  
EFFECTIVE DATE

These Articles of Incorporation shall be effective upon approval by the Secretary of State of the State of Florida.

ARTICLE III.  
CORPORATE ADDRESS

ARTICLE IV.  
CORPORATE STOCK
