**ARTICLES OF INCORPORATION
OF
A COUPLE OF BLIND GUYS, INC.**

I, the undersigned natural person, acting as incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**ARTICLE I
Name**

The name of the corporation is A Couple of Blind Guys, Inc.

**ARTICLE II
Duration**

The duration of the corporation shall be perpetual.

**ARTICLE III
Purposes**

The purpose for which the corporation is organized is to engage in the sale and installation of custom window treatments and any lawful activity under Florida law.

**ARTICLE IV
Capital Stock**

The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand (10,000) shares, consisting of one class only, designated as "Common Stock," of the par value of One Dollar (\$1.00) per share.

The principal office of the corporation is located at 27526 Big Bend Road, Bonita Springs, Florida 33923.

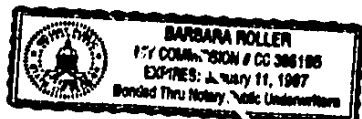

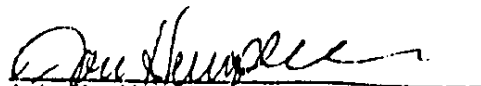

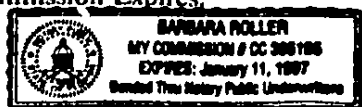
