ARTICLES OF INCORPORATION

OF

THE DOCTORS' MEDICAL CLINIC, INC.

BY THESE ARTICLES OF INCORPORATION, the Incorporator forms a corporation for profit under Florida Law.

ARTICLE I - NAME

The name of the Corporation is THE DOCTORS' MEDICAL CLINIC, INC.

ARTICLE II - TERM

This Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE


