ARTICLES OF INCORPORATION
OF

ARTICLE I: NAME

The name of this corporation is BEAUREGARD'S GROOMING SALON, INC.

ARTICLE II: DURATION

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE III: PURPOSE

This corporation is organized for the purpose of engaging in any and all activities or business permitted under the laws of the State of Florida and the United States of America.

ARTICLE IV: CAPITAL STOCK

Initial Issue. One Hundred (100) shares of stock of the corporation shall be issued for cash or notes at a value of \$1.00 per share.

ARTICLE V: PRINCIPAL OFFICE AND REGISTERED AGENT

The number of Directors may be either increased or decreased from time to time by the By-Laws of the corporation, but shall never be less than one (1). 


