ARTICLE I - NAME

The name of this corporation is D.J.'S MEDICAL BILLING SERVICE, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing these Articles with the Secretary of State of the State of Florida.
