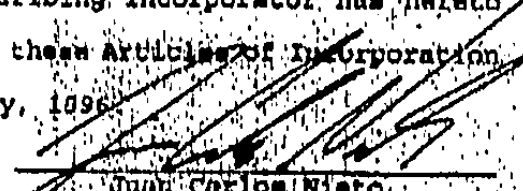
#### ARTICLE XI - AMENDMENT

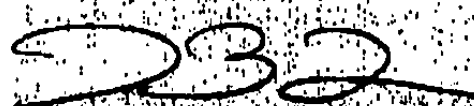
