**THE UNDERSIGNED**, acting as sole incorporator of Weird Street Productions, Inc. (hereinafter the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA") hereby adopts the following Articles of Incorporation (the "Articles") for the Corporation:

**ARTICLE I**

**Name**

The name of the Corporation is: **Weird Street Productions, Inc.**

**ARTICLE II**

**Business and Activities**

The Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE III**

**Shares**

The total number of shares which the Corporation shall have the authority to issue shall be **Ten Thousand (10,000)** shares, consisting of a single class of common stock having a par value of **\$1.00** per share.

**ARTICLE IV**

**Preemptive Rights**
