PRECISION BUILT CONSTRUCTION, INC.

The undersigned subscriber of these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be: PRECISION BUILT CONSTRUCTION, INC.. Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors.

ARTICLE 11

The general nature of the business to be transacted by the corporation shall be that provided below:

(a) To engage in to buy and sell real estate, build and develop unimproved land and conduct a general brokerage business on all forms or kinds of securities and to act as agents in the buying and selling of mortgages, equities, securities and other forms of negotiable instruments and evidences of indebtedness, and to buy and sell personal property, either wholesale or retail, to purchase, own, sell, rent, lease.

mortgage and to not as the agent in the buying, owning, solling, renting, leasing and mortgaging of property, whether real or personal or otherwise; to manufacture, acquire or dispose of real estate or personal properties, equities and securities of whatever nature or kind for both cash and credit; to buy and sell bonds, stock notes, mortgages or other indebtedness of security; to lean money either for itself or acting as agents in leaning money, either for itself or acting as agents in leaning and buying securities; to be and to secure in whatever manner in which a corporation might do and is permissible under the laws of the State of Fierida.

deal in letters patent or copyrights of the United
States or other countries; to work, operate or develop
the same or to carry on any business, manufacturing or
otherwise, which may directly or indirectly affect
those objects or any of them; to guarantee, purchase,
hold, sell, assign, transfer, mortgage, pledge or
otherwise acquire or dispose of the shares of capital
stock or any bonds, securities or other evidences of
indebtedness created by any person or corporation of
this State or any other state, nation, country, or
government, and while owner of said stock, may exercise
all the rights and privileges of ownership, including
the right to vote thereon as natural persons, might or

could do.

- (c) To loan money on roal estate and personal property.
- (d) To enter to, make or perform contracts of any kind with any person, association, corporation, municipality body politic, county, country, territory, state, government or colony, or any dependency thereof, and without limit as to amount, draw, make, accept, endorse, discount, execute and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures, and all other negotiable instruments and evidences of indebtedness whether secured by mortgage, bond or otherwise, as well as to secure the same mortgage, bond or otherwise.
- (e) To do any and all of the things herein set forth and all other things permissible by law to the same extent as natural persons might or could do and in any part of the world as principals, agents. contractors. or otherwise, and either alone or in company with others, purchase, hold, and re-issue any of the shares of its capital stock.
- (f) To act as a Trustee for any form of property, claim or right.
- remodeling of buildings and public works of all kinds, or any other structures or property, and for the improvement of real estate, and the doing of any other

business and contracting work incidental to or connected with such work, including demolition.
