**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is INTERNATIONAL SATELLITE TELECOMMUNICATIONS, INC. (the "Corporation"), Charter P96000046660.

2. The Amendment to the Articles of Incorporation described herein was adopted by the Shareholders and Board of Directors of the Corporation, the number of votes casted being sufficient for approval, on February 8, 2000, in the manner prescribed by Section 607.1003 of the Act.

3. Article 7.1 of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article 7.1, as follows:

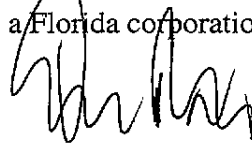
"7.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is FIFTEEN MILLION (15,000,000) shares of common stock, each share having the par value of ONE DOLLAR (\$1.00)."

4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.

5. The effective date of this amendment shall be upon the filing of these Articles of Amendment.
