## ARTICLES OF INCORPORATION OF PC PLUG & PLAY WORLD, INC.

#### ARTICLE I - NAME

The name of this corporation is PC Plug & Play World, Inc.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
