ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, heraby adopts the following articles of incorporation:

Article One

NAME

The name of the corporation is QUALITY TOWING, INC.

Article Two

DURATION

The term of existence of the corporation is perpetual.

Article Three

PURPOSE

The corporation may engage in any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

Article Four

CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is five hundred (500), which shall be common shares with a par value of one dollar (\$1.00). Shares may issued for cash, assets of determinable value, or for services rendered or to be rendered, the value of which shall be determined by the Board of Directors.

Article Five

PRINCIPAL PLACE OF BUSINESS AND REGISTERED OFFICE

The principal place of business of the corporation will be 230 Business Parkway, Royal Palm Beach Florida 33411, and the initial

registered office will be at 230 Business Parkway, Royal Palm Beach, Florida. The name of the initial Registered Agent is ELLIS ROBINS.

DIRECTORS


