ARTICLE I PREFACE

The Articles of Incorporation were adopted and approved by the board of directors on May 3, 1996.

NAME OF CORPORATION

The name of this corporation is:

ARTICLES X - AMENDMENTS

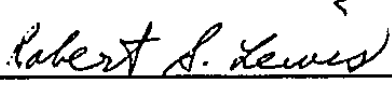

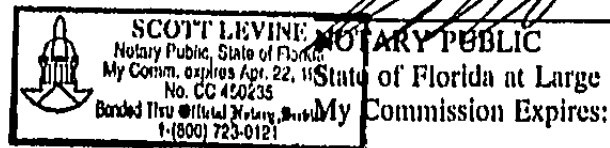
