**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is Randy's Repair, Inc.

ARTICLE II - LOCATION

The principal office of Randy's Repair, Inc. is located at 1170 Oslo Road, Vero Beach, Florida 32962.

ARTICLE III - DURATION

The period of duration is perpetual.

ARTICLE IV - PURPOSE

The purpose of the corporation is to engage in the automotive repair business and in any other activities or business permitted under the laws of the United States or the State of Florida.

ARTICLE V - CAPITAL STOCK

The corporation shall have the authority to issue 100 shares of common stock of \$1.00 par value per share.

ARTICLE VI - RESTRICTION ON SALE OF STOCK

The corporation shall have the power to include in its by-laws any regulatory or restrictive provisions relating to the proposed sale, transfer or other disposition of any of its outstanding stock by any of its shareholders or in the event of the death of any of its shareholders. The manner and form, as well as all relevant terms, conditions and details thereof shall be determined by the Board of Directors of this corporation; provided, however, that no such regulatory or restrictive provision shall affect the rights of third parties without actual knowledge thereof, unless such provision or notice thereof shall be plainly written upon the certificates evidencing the ownership of said stock.

ARTICLE VII - INITIAL REGISTERED OFFICER AND AGENT

The initial registered agent shall be Randy Jaynes and the address of its initial registered office is 1170 Oslo Road, Vero Beach, Florida 32962.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

The number of Directors constituting the initial Board of Directors is One (1) and the names and addresses are:


ARTICLE X - AMENDMENTS

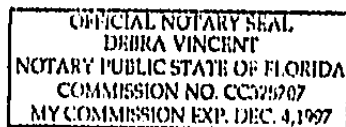




