ARTICLE I. CORPORATE NAME.

ARTICLE VII. INCORPORATOR.

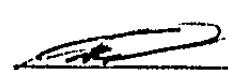

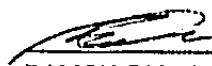
ARTICLE VIII. POWERS.
