



OF

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I: NAME**

The name of the corporation shall be Frankie's Pizzeria, Incorporated and the principal place of business of this corporation shall be 7220 Manatee Avenue West, Bradenton, FL 34209 and the mailing address of the corporation shall be 7220 Manatee Avenue West, Bradenton, FL 34209.
