

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME AND ADDRESS

The name of this corporation is THE BEST COMPLETE FLOOR CARE CORP and its business address is 1310 N.E. 129th Street, North Miami, Florida 33161.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - PURPOSE

ARTICLE IV - CAPITAL STOCK

Every shareholder, upon the sale for cash any new stock of this corporation of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED AGENT AND OFFICE

THE BEST COMPLETE FLOOR CARE CORP. desiring to organize under the laws of the State of Florida with its principal office as indicated in the Articles of Incorporation at 1310 N.E. 129th Street, North Miami, Florida 33161 has named Georges Pierra-Louis, as its agent to accept service of process within this state.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) Director initially who shall serve until her successor, if any, are elected at the shareholders' annual meeting. 
