ARTICLES - NAME

The name of this Corporation is TIMOTHY B. TABOR, MD., P.A.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by the Corporation and its objects and powers shall be as follows:


ARTICLE VIII - INDEMNIFICATION




