

ARTICLE I. NAME

The name of the Corporation is CFYC, INC. The principal place of business of this Corporation shall be 313 South Palmetto Avenue, Daytona Beach, FL 32114.

ARTICLE II. PURPOSE

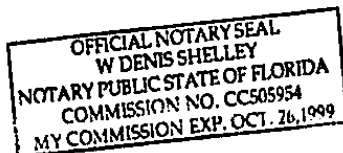


