ARTICLE ONE

The name of the corporation is **A MOTHER & DAUGHTER SECRETARIAL and CONSULTANT SERVICES, INC.** The principal address of the corporation is **P.O. BOX 1297, FORT LAUDERDALE, FL. 33302.**

The period of its duration is perpetual.
